#### **ABOUT JSMP**

The Judicial System Monitoring Program (JSMP) was established in 2001 in Dili, Timor-Leste to monitor the processes of the Ad Hoc Human Rights Tribunal in Indonesia and the Special Panels for Serious Crimes in Timor-Leste.

JSMP now exists as a Timorese led not-for-profit organisation working to improve the judicial and legislative systems in Timor-Leste through independent monitoring, analysis and community education. Our aim is a formal justice system where the legal rights of all citizens are respected and protected in accordance with international human rights standards.

JSMP conducts monitoring activities on trial processes in the district courts and the Court of Appeal and reports on developments in the formal justice system. Based on its monitoring activities JSMP publishes thematic reports, including an annual report on the formal justice system, Justice Updates, press releases, case summaries and analysis of draft legislation.

JSMP also provided training sessions as part of efforts to increase the understanding and awareness of the community, the police, women's groups, local authorities, Village Councils, students and journalists about human rights, justice and the law.

The vision of JSMP is to be the foremost independent organisation in Timor-Leste contributing to the development and improvement of the judicial and legislative system through objective monitoring, analysis, advocacy and training.

#### FOREWORD BY THE DIRECTOR

In 2011 JSMP undertook a number of activities to help achieve the vision of the organisation including, but not limited to:

- monitoring over 450 court cases across Timor-Leste
- providing training to over 1,000 individuals
- producing 68 press releases, 3 television programs and 4 radio programs
- organising and facilitating an international seminar with over 190 guests from around the world
- providing legal advice to over 250 new clients in cases of domestic violence and sexual assault through the Victim Support Service

These activities were completed by a team of 41 Timorese staff members with assistance from international advisors.

In 2011 JSMP also worked to strengthen oversight mechanisms available to the members of the JSMP Board. This was done to ensure that the JSMP management system remains credible and transparent.

2011 was also an important year for JSMP and VSS with the JSMP Board endorsing the decision for VSS to separate from JSMP and form an independent legal aid organisation. JSMP management will continue to provide guidance to VSS during the transitional period which will end at the beginning of 2013.

#### 2. OVERVIEW OF JSMP PROGRAMS

#### A. Court Monitoring

In 2011 JSMP monitored activities in the four district courts and the Court of Appeal. Monitoring activity in Baucau and Suai were intensified during this period following the opening of JSMP offices in these districts in late 2010 and 2011 respectively. The majority of monitoring activity was carried out in Dili, Baucau and Suai as trials took place each day in these three courts. Monitoring in the Oecusse District Court was hampered by the fact that trials rarely take place due to a number of technical problems, including a lack of facilities and court actors.

A total of 410 cases were monitored by the Legal Research Unit (LRU) in 2011, comprising 18 civil cases and 392 criminal cases. The Women's Justice Unit (WJU) monitored 68 cases involving gender based violence. **Annex 2** provides statistics on cases monitored by the LRU between January and December 2011, while **Annex 3** provides statistics on cases monitored by the WJU between January and December 2011.

#### **B.** Legislative Analysis

JSMP provided commentary and legislative analysis on the draft Civil Code, in particular Books III and IV regarding property and land rights. This analysis was submitted to the National Parliament for consideration, however unfortunately the Civil Code was approved in one day without consideration of the issues raised by JSMP and other civil society organisations.

JSMP will continue to engage with the legislative process in 2012 including lobbying the National Parliament to ensure that the Institute of Memory and Reparations laws are debated. The debate and passage of these laws is an important step to ensuring that victims and their families are provided with appropriate reparation for past human rights abuses in Timor-Leste.

#### C. Training and Focus Groups

In 2011 JSMP developed and delivered training to more than one thousand participants, including journalists, the police, women's groups, community groups and youth groups. Topics covered during training included; the Law Against Domestic Violence (LADV), the Penal Code, Criminal Procedure Code, the Timor-Leste Constitution and relevant international laws. For details of training programs, including further information about topics covered, see **Annex 4** and **Annex 5**.



In addition to training programs, seminars were organized for 6 Senior High Schools and 3 Universities. These seminars were aimed at raising the knowledge of participants about the Penal Code and the LADV. The seminars aimed to encourage students, particularly female students, to complete their studies at high school, and discussed the benefits of pursuing law as a future career. JSMP works to encourage young women to study law at university in the hope that they will attend the Legal Training Centre and become judges, prosecutors and lawyers and ensure gender balance amongst judicial actors.

In 2011 JSMP also conducted focus group discussions in Maliana and Dili to gain community feedback regarding the draft Civil Code. A total of 57 attendees participated in these focus group discussions. The results of these discussions were compiled and included in JSMP's submission on the Civil Code

#### D. Seminars

The Parliamentary Watch Program of JSMP organized a national seminar titled: *The National Parliament Meets the People*. This seminar was held in September 2011 and was attended by over 60 representatives of Suco Councils from the districts of Dili, Liquica, Maliana and Viqueque. At this seminar the Deputy President of the National Parliament and the President of Committee A as well as representative for the opposition party Fretilin were all speakers at this event. The seminar provided an opportunity for community representatives to discuss their opinions and concerns directly with MPs.

In November 2011 JSMP and Amnesty International organised an international seminar titled: *Justice and Accountability for Past Crimes*. This seminar was held in Dili and was attended by over one hundred and ninety people, including representatives from Amnesty's strategic partner in Indonesia, KontraS, representatives from Amnesty International and representatives from government, parliament, civil society, victims groups and the judicial sector.



To celebrate Timor-Leste's annual 16 day campaign to stop violence against women, JSMP collaborated with FOKUPERS to organize a national seminar titled: *The Role of Witnesses in Cases of Domestic Violence*. This seminar took place on 17 November 2011 was supported by the Norwegian Embassy in Jakarta. Present at the seminar were representatives from the Norwegian Embassy and high ranking Timorese officials, including Her Excellency Ana Pessoa, Prosecutor-General, Her Excellency Idelta Maria Rodriquez, Secretary of State for the Promotion of Equality

and Ms. Ingrid Fiska, Deputy Minister for International Development from Norway. The seminar was also attended by participants from the government, NGOs and academics. A total of approximately one hundred and eleven participants attended this seminar.

#### E. Publication of Press Releases, Justice Updates and Reports

In 2011 JSMP published 68 press releases concerning court activities, trial procedures and outcomes, parliamentary activities and training and workshops organized by JSMP. JSMP organized press conferences and media briefings on issues such as the Reparations Law and the Public Institute of Memory Law and published two Justice Updates on the Civil Code and court decisions in a 'crimes against humanity' case involving Valentim Lávio.

JSMP published a number of reports during 2011 including:

suggestions for interpretation of the LADV.A report on Legal Protection for Victims of Gender Based Violence: Laws Do Not Yet Deliver Justice

 A report in conjunction with Charles Darwin Universit titled: Strengthening the Capactiy of Health Professionals and Lawyers to Understand and Apply the New Penal Code and Domesitc Violence Law Using a Human Rights Framework

All press releases, Justice Updates and reports were published and distributed to the national and international media and JSMP donors and partners through the JSMP mailing list and JSMP website. These publications were also distributed to court actors, community members, MPs, Universities and Embassies as well as other relevant institutions. #### F. Television and Radio Programs

In 2011 JSMP produced television and radio programs covering topics such as witness protection, the role of advocacy in the administration of justice, government obligations in relation to the Law Against Domestic Violence, the role of the media in the promotion of children's rights, legal impunity and the role of the police and local authorities in helping victims of gender based violence access the formal justice system.

#### G. Advocacy and Information Dissemination

Throughout 2011 JSMP undertook the following advocacy and information dissemination activities:


- JSMP, together with several national and international organizations such as Amnesty International, Forum Asia, ICTJ Timor-Leste, ANTI, the HAK Association, Victim's Association, STP-CAVR and others provided joint advocacy on justice and human rights issues.
- As part of an advocacy campaign JSMP and FOKUPERS wrote a letter to the F-FDTL institution regarding a member of F-FDTL whose maltreatment of an old woman resulted in her death in Mascarenhas, Dili.
- JSMP and FOKUPERS held discussions with the Baucau Public Prosecution Service, including judges from the Dili District Court, to discuss incest cases, specifically those where the perpetrators have been acquitted.

- JSMP participated in the Technical Drafting Committee for the National Action Plan on Gender Based Violence. The National Action Plan is designed to implement the Law Against Domestic Violence across all relevant ministries and stakeholders.
- JSMP produced booklets on domestic violence and disseminated them to legal and medical professionals in order to assist these professionals to understand and uphold their responsibilities towards victims. The title of the booklet was: The role of legal and medical professionals in handling domestic violence pursuant to Law No. 07/2010 Against Domestic Violence.
- JSMP produced flyers containing information on domestic violence as a public crime to increase community awareness and encourage those who see or know about an incident of domestic violence to report it to the nearest police station or the Public Prosecution Service.
- T-shirts and bags were also produced and disseminated with the messages 'Justice for women is justice for all' and 'Stop violence against women'.

#### H. Provision of Legal Advice

In 2011 VSS provided legal advice to women and child victims in all of the Districts within Timor-Leste. The tables below show the total number and type of cases handled by VSS in 2011.

Table 1: Total number of new VSS clients between January - December 2011



As shown in Table 1, the average number of new cases handled by VSS each month was between 14 and 30. VSS received these clients through established referral networks including other service providers such as Pradet and FOKUPERS. Most VSS clients were referred by the PNTL Vulnerable Person Units (VPUs) while some clients also came directly to VSS. Clients were referred from all 13 districts across each of the four jurisdictions.

In addition to new cases, VSS provided ongoing assistance throughout 2011 to clients from previous years whose cases had not yet been resolved by the formal justice system.

The table above shows that, in 2011, VSS provided legal assistance to 252 new clients, with the vast majority of cases involving domestic violence. Despite these women and children opting to provided information to the police and the Public Prosecution Service with the support of VSS, JSMP observed that the process continued to be impeded by a lack of strong evidence, changes in victims place of residence making it difficult to locate victims during lengthy judicial processes and human resource limitations within the courts. As shown in Table 3 below, of the new 2011 cases, only 10 VSS clients had their cases decided by one of the four district courts, four cases were archived by the Public Prosecution Service due to a lack of evidence, and one case was dismissed by the court. Meanwhile, in five cases the victim refused to make a report to the police. The vast majority of cases remain pending at the Public Prosecution Service.

#### 3. STAFF CAPACITY BUILDING

In 2011 JSMP provided many opportunities for staff to improve their capacity both domestically and internationally. All JSMP program staff attended training sessions on the Penal Code, the Criminal Procedure Code and the Law on Witness Protection. These training sessions were followed by regular internal workshops to discuss legislative analysis and certain cases or problems identified in relation to cases. All JSMP staff were provided with the opportunity to attend English classes. Some staff chose to attend formal classes outside of JSMP while additional classes were offered to all staff internally within JSMP. Internal classes were facilitated by international advisors working within JSMP. Throughout 2011 five international advisors worked at JSMP in a capacity development role building both management and technical skills.

A number of staff members attended training overseas. Members from the Parliament Watch Program attended training on parliamentary monitoring in the Philippines for three months, a member from the Outreach Unit attended training on ASEAN human rights mechanisms in Jakarta, Indonesia and four VSS staff participated in a study exchange to Jakarta in preparation for the separation of VSS from JSMP at the end of 2012. The Director of JSMP also attended training in Sweden on the topics of peace security and human rights while the Deputy Director attended training on human resource management in Timor-Leste and training on fundraising in Thailand.

#### 4. JSMP FUNDING

JSMP Management has tried to ensure the continuity of the institution by seeking funds from a number of donors. In 2011 JSMP programs were fully supported by funds from the Asia Foundation, Justice Facility, Norwegian Embassy, AusAID, UNFPA and MISEREOR. The following information details the programs funded by each donor and the period of funding<sup>1</sup>:

# 5. STRENGTHENING LINKS WITH INSTITUTIONS AT THE NATIONAL AND INTERNATIONAL LEVEL

#### A. Building a Strategic Partnership with Amnesty International

JSMP has had a strong relationship with Amnesty International since JSMP was established in 2001. In 2011 representatives from Amnesty International's Central Office in London visited JSMP to discuss how to further strengthen this partnership through the creation of a new 'strategic partnership'. Since this time a joint agreement has been finalized and Amnesty International, together with its partner KontraS in Indonesia, have provided a number of training sessions including training on media, advocacy and fundraising.

As part of the new strategic partnership JSMP and Amnesty International together organised a national seminar regarding impunity for past human rights violations and JSMP, as the strategic partner of Amnesty International, attended a conference in the Netherlands.

JSMP and Amnesty International will continue this strategic partnership in 2012 and beyond.

# B. Involvement in the Forum Asia and ASEAN Network on National Human Rights Institutions (ANNI)



JSMP has been a member of Forum Asia since 2007 and, in May 2011, was invited to speak at a workshop held in South Korea on *Judicial Monitoring Activities in Timor-Leste*. At this workshop JSMP presented a paper on the Timor-Leste justice system and challenges faced by JSMP in conducting court monitoring.

JSMP is also a member of ANNI and, in September 2011, JSMP was asked to write a report about the Ombudsman for Human Rights

and Justice. This report was launched at the Asia Pacific Conference of National Human Rights Institutions in Thailand.

#### C. Strengthening Links with National Organisations and Government Institutions

In addition to strengthening and extending links at the international and regional level, JSMP has fostered strong relationships with government institutions, NGOs and religious institutions in Timor-Leste with the aim of generating public support and increasing collaboration in order to ensure ongoing development of the formal justice system.

JSMP staff have regularly attended meetings and working groups with stakeholders in Timor-Leste including:



• regular monthly Referral Network meetings on protection of women and of children led by the Ministry of Social Solidarity

- monthly discussions about the draft law on human trafficking organized by the Ministry of Foreign Affairs
- monthly meetings and district based consultations of the Technical Drafting Committee on the National Action Plan on Gender Based Violence
- regular participation in the Coalition for Children's Rights working group responsible for monitoring the implementation of the Convention on the Rights of the Child in Timor-Leste.
- monthly meetings and collaboration with female lawyers undertaking activities such as conducting a comparative study in Jakarta and evaluating women's needs in relation to the law
- regular attendance at the Gender Responsive Budgeting working group organized by UN Women
- involvement in the UN Resolution 1325 working group led by the gender section of UNDP and attendance at a UN Resolution 1325 workshop in Bangkok
- organisation of meetings with the Bishops of Baucau and Dili, as well as Muslim representatives,
  Acting Special Representative of the Secretary-General for Timor-Leste and Head of UNMIT, Mr.
  Finn Reske-Nielsen, Vice Prime Minister Mr Jose Luis Guterres and the Commander of F-FDTL Mr
  Taur Matan Ruak to introduce the work of JSMP
- participation in a discussion group on the draft Children's Code
- attendance at a workshop coordinated by the Alola Foundation regarding women in Asia
- attendance at regular Protection Cluster meetings to share information and ideas concerning the rights of women and children in emergencies
- organisation of a meeting with prosecutors to discuss incest cases
- participation in a National Good Governance seminars organized by UNMIT
- participation in a national seminar organized by the AATL entitled: Law Week at the President's Palace in Dili.

JSMP also participated in the celebration of International Women's Day on 8 March 2011.

#### 6. THE FUTURE OF JSMP

Based on activities detailed in the JSMP Strategic Plan, JSMP will focus on the following core activities in 2012:

#### Management

- Continue to sources of funding to support the continuity of JSMP programs.
- Identify and draft new policies to further strengthen internal regulation. In addition, management will raise awareness about existing policies and conduct reviews as required.
- Oversee the transition of VSS from a Unit within JSMP to an independent organization.
- Evaluate the performance of program coordinators.
- Continue to identify potential improvements to the JSMP financial management system.
- Continue to facilitate the annual JSMP external evaluation and financial audit.
- Conduct the annual review of the JSMP Strategic Plan.
- Finalize the review of the JSMP Constitution.
- Undertake capacity building for the Director, Deputy Director and Program Coordinators.
- Further strengthen relationships with core partners in Timor-Leste including court actors, the parliament, the government and NGOs.
- Extend and improve links with international stakeholders.

#### Legal Research Unit

- Strengthen the strategic partnership between JSMP and Amnesty International. This partnership will
  be exercised in the form of several important activities such as seminars, trainings, capacity building
  and joint advocacy.
- Disseminate information to the public on the Timor-Leste justice system. The regular provision of information will be achieved through a series of publications produced by the LRU, such as press releases, Justice Updates, case summaries and thematic reports.
- Provide training to community leaders and police on the Penal Code to strengthen community awareness of criminal procedure in Timor-Leste.
- Monitor cases in the four district courts in Timor-Leste and continue to seek access to monitor hearings in the Court of Appeal.
- Monitor all plenary sessions of the National Parliament and sessions of Committee A to analyse the
  performance and conduct of the parliament and provide submissions analysing significant draft laws
  which impact on the justice system and human rights.
- Continue to advocate for improvements to the justice sector and conduct of trial by the courts through issuing legal opinions, Justice Updates and lobbying judicial actors.
- Organise a national seminar on witness protection laws.

#### Outreach

• Disseminate information through training to community members, students, the police and other stakeholders.

- Disseminate information to stakeholders through radio, television and the media.
- Work to develop and continue relationships with key stakeholders both within Timor-Leste and internationally.
- Increase the quantity and quality of information available on the JSMP website.
- Increase the capacity of staff regarding advocacy campaigns, website establishment and maintenance and English language skills.

#### WJU

- Monitor cases involving women and children in the four district courts, with specific attention on cases of domestic violence, sexual assault and incest.
- Provide training from a gender perspective to women and female youth on the topics of the Law Against Domestic Violence, the Timor-Leste Penal Code and the Timor-Leste Criminal Procedure Code.
- Prepare and publish press releases, Justice Updates and reports as well as produce brochures, booklets, t-shirts and bags in order to disseminate information to the community about gender based violence.
- Produce radio programs to highlight the issue of violence against women and explore the topic of women's access to justice.

#### **VSS**

- Continue to provide legal advice and material support to women and children who are victims of gender based violence in all of the jurisdictions of Timor-Leste.
- Continue to play a role in coordination and referral regarding gender based violence.
- Increase the understanding of communities and students living in isolated areas about the rights of women, the justice system and gender based violence.
- Strengthen internal resources, including providing adequate facilities to support the work of the VSS.
- Strengthen the relationship between court actors including through entering into an MOU with the Public Prosecution Service.
- Develop the capacity of national staff in relation to drafting legal analysis and improving their ability to use English.
- Make the transition from a JSMP unit into an independent organization that provides support to victims. This includes independent management and organization of finances and programs.
