## Celebrating the 21<sup>st</sup> Anniversary of JSMP: JSMP launches its annual reports on the Justice, Legislative and Institutional Sectors for 2021

On 28 April 2022 JSMP celebrated its 21<sup>st</sup> anniversary and at the same time launched three reports, namely the **Overview of the Justice Sector Report, The Parliamentary Watch Report and Institutional Report**.

These three annual reports provide results of regular observations carried out by JSMP at the courts and the National Parliament, legal aid activities for female and child victims and the expenditure for JSMP activities during 2021.

"Each year to celebrate the anniversary of JSMP, 3 annual reports are always launched, whereby two of these reports relate to progress and challenges in the judicial system and the National Parliament. However, in the justice sector report for 2021, JSMP has included an extra topic on legal aid activities for female and child victims. Meanwhile the other report discusses JSMP activities that were implemented in 2021," said Ms. Ana Paula Marcál, Executive Director of JSMP.

the Overview of the Justice Sector Report discusses progress and challenges in the Justice Sector and discusses cases involving gender based violence and corruption, and reports on JSMP's legal aid activities for female and child victims, and also includes statistics about cases processed by the district courts and the Court of Appeal during 2021.

The Parliamentary Watch Report discusses the functioning of the National Parliament in relation to the productivity of parliament regarding legislation and analyses political influence on the legislative process in the National Parliament.

Meanwhile, the JSMP Institutional Report provides a summary of JSMP activities performed throughout 2021 including institutional cooperation with key institutions and national and international networks. This report also outlines funding support that JSMP received from donors which provides legitimacy and public accountability.

This report concludes with a number of important and relevant recommendations that are addressed directly to the competent organs and institutions for their consideration. JSMP hopes that these important recommendations will be given consideration in order to improve the functioning of the formal justice system and legislative system now and in the future.

In addition to the celebration of this anniversary and launch of these reports, JSMP also received messages from relevant parties who have continued to support JSMP in the performance of all of its activities, namely:
