Statements of the Chief of Timor-Leste's Defence Force concern RDDU as they can endanger the future of the Timor-Leste's democratic rule of law

Timor-Leste's Human Rights Defenders Network-*Rede Defensór Direitus Umanus* (RDDU)asks everyone, and especially the leadership of the State being an example to the people, to uphold highly and promote the principles and values of human rights, justice and democracy.

In the process to liberate the nation, human rights were the fundamental basis for the struggle and defense of the people of Timor-Leste. Finally, we achieved the right to self-determination and terminatedthe suffering of the people from the illegal Indonesian military occupation.

Everyone including the leaders is proud as our Constitution of Republic is among the best in the world, as it guarantees firmly human rights equally for all. In addition, the State has ratified7 human rights treaties. Thus, we ask the leaders of the State to show commitment to human rights according to the promises set out in the law.

The Human Rights Defenders Network-Rede Defensór Direitus Umanus is concerned with the following public statements:

1. Bythe Chief of Timor-Leste Defence Force who, according to public infomation on 21 December 2016, released a statement to encourage the security force during the Christmas and New Year to use excessive force and shoot and break the legs of those who committerime while on the run. Based on information reported, the Chief of Defence Force noted "don't be afraid with human rights".

The Human Rights Defenders Network-*Rede Defensór Direitus Umanus* asks the security forces to intervenein accordance with the law and respect for human rights, and only use force if necessary and proporsionally. RDDU also uses this oportunity to express that we condenm criminal acts which some youth have been involved in and that do not contribute to stability, and impact negatively on people's liberty and security. Everyone, including young people, has rightsbut also a duty to respect the rights of others.

2. Bythe Chief of Timor-Leste Defence Force reportedly made on 1 December 2016and reported in the media, that he will not give oportunity and promote children of militia in the F-FDTL.²

We as human rights defenders continue to demandacountability for human rights violations that occured during the struggle for independence, including by the militia. But children are not responsible for the acts of the their parents who they were militia at in that time. RDDU

Therefore, RDDUasks:

- 1. To the leadersnot to generate words that do not match the principles and values of human rights.
- 2. To the security forces to perform their duties according to the law, including when using force so that this is always based on law and is proportional
- 3. To the F-FDTL commander to provide equal oportunities to F-FDTL members regardless of their parents background.
